1. To act, appear and plead in the above-noted case in this court or in any other court in which the same may be tried or heard, and in appellate courts (including the High Court) subject to payment of fees separately for each court by me/us.
2. To sign, file, verify and present pleadings, appeals, cross-objections, petitions etc. for execution, review, revision, withdrawal or compromise, with any affidavits (or other documents) as may be deemed necessary or proper for the prosecution of the said case in all its stages subject to payment of fees for each stage.
3. To file and take back documents; to admit and/or deny documents of the opposite party.
4. To withdraw or compromise the said case or submit to arbitration any differences or disputes touching or in any manner relating to the said case that may arise.
5. To take execution proceedings.
6. To deposit, draw, and receive moneys, cheques, or cash, and to grant receipts therefor and to do all other acts and things which may be necessary to be done for the progress of, and in the course of the prosecution of the said case.
7. To appoint and instruct any other legal practitioner whenever he/she/they may think fit, authorizing him/her to exercise the power and authority hereby conferred upon the advocate(s), and to sign powers of attorney on my/our behalf.
8. And I/We the undersigned agree to rectify where necessary, and accept/confirm all acts done by the advocate(s) or his/her/their substitute(s) in the matter as acts done by me/us for all intents and purposes.
9. And I/we undertake that I/we or my/our duly authorized agent will appear in court on all hearings.
10. And I/We the undersigned do hereby agree not to hold the advocate or his/her substitute responsible for the result of the said case. The advocate shall be entitled to receive and retain as his/her own any adjournment costs awarded by the court.
11. And I/We the undersigned do hereby agree that in the event of any part of the agreed fee remaining unpaid, he/she/they shall be entitled to withdraw from the prosecution of the said case until the same is paid up. The fee settled is only for the above case and the above Court.
